**Vote for real tax transparency and citizens' access to information**

Dear Mrs. Zimmer,

The European Parliament has demonstrated strong leadership in the much-needed fight for transparency around what multinational corporations pay in taxes. Members of the European Parliament have vehemently reacted to tax scandals such as LuxLeaks and the Panama Papers by proposing concrete actions to end corporate tax avoidance.

On Tuesday 4 July, the European Parliament will vote on draft legislation requiring large multinational groups to publicly report information on their profits, turnover, taxes, number of employees, and other relevant financial information – a measure commonly referred to as public country-by-country reporting (public CBCR).

***We are writing to you as the leader of the GUE/NGL group in the European Parliament to call for your support to increase corporate transparency and public CBCR. We ask you to vote to amend the current text in Plenary in order to ensure that the legislation can fully deliver on its objectives to combat tax avoidance by large multinational corporations.***

The objective of the legislation is to provide society at large with information about the key activities and tax payments of multinational corporations operating in their countries, shed a light on multinationals' profit shifting techniques as well as deter corporations from engaging in aggressive tax planning schemes. Public scrutiny of this information will allow public debate about the tax strategies of large multinationals, as well as improve corporate accountability and transparency.

We welcome the European Parliament's significant attempt to improve the European Commission's proposal by extending the reporting requirement for multinational corporations to all of their countries of operation, as opposed to EU member states and yet-to-be determined tax havens only. However, we are concerned about a new provision that was introduced during the vote of the ECON and JURI Committees on 12 June, when MEPs voted to adopt a 'get out clause' for multinationals. This new clause would limit transparency over some of their activities in certain countries and citizens' full access to information about large multinationals' tax payments.

This clause has been adopted despite the uncertainty regarding the loopholes it might create. There is also a risk that this clause could encourage aggressive tax competition. Member states may start competing with one another by granting weaker standards to multinationals in order to attract them.

We therefore urge you to vote in favour of an amendment to the current text in order to ensure that proper transparency becomes a reality. This would provide for a more balanced approach by ensuring the necessary level of transparency to create a real disincentive for large-scale tax avoidance, while at the same time protecting corporations' sensitive data.

We remain at your disposal should you wish to receive further information or if you would like to meet in person to discuss the European Commission's legislative proposal further.
