## Integrity Pacts at European Week of Regions and Cities 2020

On 5-24 October 2020, the annual [European Week of Regions and Cities](#) (EWRC) will virtually bring together local and national authorities, EU representatives, civil society, academia and the private sector to foster citizen participation in cohesion policy and exchange best practices to pave the way towards a Greener Europe. This year's EWRC will be spread over three weeks, each focused on a different theme: 1) Empowering Citizens, 2) Cohesion and Cooperation, 3) Green Europe.

We are currently faced with an unprecedented health crisis, the recovery from which will heavily rely on EU funds and cohesion policy, therefore the safeguarding of funds, citizen participation, and transparency in public procurement have become even more vital.

During this year's online EWRC, Transparency International will share its experience in engaging citizens through Integrity Pacts – a civic monitoring tool to safeguard public contracting from fraud and corruption. Since 2016, Transparency International and the European Commission have been [piloting Integrity Pacts](#) across 11 Member States to ensure that 18 EU-funded investments deliver for the common good.

### **Empowering Citizens**

#### **Join the Civic Mapathon!**

*Wednesday 7 October 2020*

*09:30 – 11:00 CET*

With speakers from the Transparency International Secretariat, Transparency International Italia, and the European Commission, the session will showcase an innovative way for involving affected communities in civic monitoring through technology. Building on the work of Transparency International Italia for the monitoring of a tram construction in Cagliari, Sardinia, this online Civic Mapathon will demonstrate that citizens can contribute to the planning of a large public works project with only a smartphone, tablet or computer and good internet connection. Participants will learn how georeferencing can stimulate the engagement of citizens in monitoring tenders and infrastructure projects.

### **Cohesion and Cooperation**

**Anti-fraud strategies and the regions. The important role the regions can play in the fight against fraud and corruption, in particular in the context of crises.**

*Tuesday 13 October 2020*

*11:30-13:00 CET*

Fraudulent actions to misuse public, including EU, funds happen regularly. The rapidly evolving nature of fraud and the increasingly complex schemes it entails offer many opportunities to fraudsters. When fraud occurs, its impacts are multiple and manifest on various levels: Fraud and corruption not only have a financial but also a social and personal cost; they jeopardise the efficiency of governance, democracy, equal opportunities, competitiveness and quality of life. Finally, fraud and corruption constitute a high reputational risk for the authorities that manage and implement the funds. All these risks are heightened by the current crisis, to counter which the correct use of public (and European) funding is even more important.

In this session organised by OLAF, Nick Aiossa (Deputy Director at Transparency International EU) will be joined by representatives from the European Commission and Parliament to discuss Integrity Pacts and other tools that can help to combat fraud and corruption in EU funds.
